PLEASE BE AWARE THAT YOUR PET(S) MUST BE KEPT IN GOOD CONDITION, AND FOR DOGS THEIR NAILS MUST BE REGULARLY TRIMMED. YOU WILL BE REQUIRED TO SIGN A PET ADDENDUM TO THE TENANCY AGREEMENT ACCEPTING FINANCIAL RESPONSIBILITY FOR ANY DAMAGES CAUSED BY YOUR PETS. PERSISTENT BARKING MAY BE DEEMED A CAUSE FOR ENDING TENANCY. BREEDING OF ANIMALS IS STRICTLY PROHIBITED IN THE BUILDING.

The Tenancy Agreement will state:

13. PETS. Having regard to the enjoyment, quiet possession, safety and health requirements of other occupants in the residential property, as well as the nature of the property; **the Tenant shall not keep, or allow to be kept, any animals or pets, domestic or wild, fur bearing or otherwise** unless **specifically permitted in writing by RPM**, which permission may be revoked by RPM at any time, particularly having regards to the factors set out above, which factors are not all inclusive. Where RPM has given this permission in writing, the Tenant shall ensure that the pets and animals do not disturb the other occupants in the residential property or adjoining property, and further the Tenant shall ensure that no damages occur to the residential property, as a result of having the animals and pets. This is a material condition of the agreement: If any damages occur of any nature whatsoever caused by the said pets or animals, the Tenant shall be liable for such damages and shall pay RPM sufficient monies to compensate RPM in respect to the damage, expenses, legal fees or any other reasonable costs incurred by RPM. Further RPM gives notice to the Tenant to correct any breach or if RPM revokes the permission and the Tenant fails to comply immediately, RPM has the right to terminate the tenancy immediately along with making the appropriate claims against the Tenant. Having regard to the potential noise and mess, the Tenant shall not encourage or feed wild birds at or near the residential property.
